Project Description

The U-District Partnership (UDP) in collaboration with the U-District Conversation on Homelessness (UDCH) is undertaking a feasibility study for one or more permanent public restrooms in the U-District. Given the lack of access to public restrooms in the neighborhood, the community has strongly advocated that the need for clean, safe, and easily accessible public restrooms is a public health necessity. The project aligns with the mission of the UDP to "make the U-District a better place to live, work, and play for the whole community", and is funded by the City of Seattle's Department of Neighborhoods (DON).

The approximate project timeline is July-December 2015, with broad community outreach and engagement expected to begin mid-October. Evaluation of the public involvement process is expected in late November, with technical review of potential sites and recommendations for next steps provided in early December.

Project Goals

Given the high visibility of this project, a significant level of public involvement is expected. Project funding requires a community "match", in the form of volunteer labor hours, which will be a key component of the outreach process.

The goals for public engagement are:

- 1. Raise awareness that increased access to public restrooms for all members of the U-District neighborhood is a public health necessity.
- 2. Develop a network of broad community support for building a public restroom(s) in the U-District.
- 3. Actively solicit and consider community input on the best location(s) and design for new public restroom(s).
- 4. Work directly with the public throughout the process to ensure that issues and concerns are consistently understood and considered.
- 5. Implement best practices for broad and inclusive community engagement.
- 6. Achieve 367 hours of volunteer labor to meet matching fund obligations.
- 7. Host 10 tabling events at the Farmers Market, UW Bookstore and Bulldog News.

Messaging

- 1. Clean, safe, readily accessible public restrooms are a public health necessity; we're working with the community to figure out where one or more should be located.
- 2. This planning effort is supported by the UDP and UDCH as part of the vision to create a vibrant and innovative district of students, entrepreneurs, major employers, talented workers, and diverse residents.
- 3. Meeting community need is critical, and this planning effort includes developing an operational agreement to ensure any facility is well managed, clean, and safe.

Outreach Approach

The project will adhere to the six essential strategies for inclusive engagement, as detailed in the City of Seattle's Inclusive Outreach and Public Engagement Guide:

- 1. Build personal relationships with the target population.
- 2. Create a welcoming atmosphere.
- 3. Increase accessibility.
- 4. Develop alternative methods for engagement.

- 6. Partner with diverse organizations and agencies.

A variety of outreach approaches will be used in order to meet these established best practices for achieving broad public participation, including presenting at community events, briefing local organizations and community leaders, communicating through blog posts and social media, updating the project's website, and hosting at least one community forum. Evaluation

All public engagement efforts will be documented and incorporated into a Public Involvement Evaluation report due at the end of November 2015.
